During May, like many law enforcement agencies around the state and the country, North Carolina Fraternal Order of Police recognizes our law enforcement heroes across our state who made the ultimate sacrifice during the previous year. This year, for the first time, NCFOP partnered with NC Concerns of Police Survivors to host a "Celebration of our Law Enforcement Heroes." This was the first year this event was sponsored and hosted totally by our two organizations. Both NCCOPS and NCFOP have participated in a similar event for many years. After last years' service, NCCOPS and NCFOP began to make plans to have our own celebration for the heroes and their families. Relying a great deal on what our partners with NCCOPS felt was needed, we developed the celebration many of you witnessed on April 18th at Lamb's Chapel in Burlington. I am so grateful for the relationship between our two organizations and proud we were able to provide a celebration to honor the nine officers we lost in 2022 and two additional officers from 2021. From the beginning of the planning for this celebration, we were determined to make this about the officers and the way they lived their lives outside of law enforcement. We can only hope we were able to accomplish that and bring a smile to faces of the folks who have lost so much. In this edition of the BlueNote, you will see several articles and a number of pictures from the celebration.

Many local FOP lodges, as well as law enforcement agencies, will be hosting events to honor the lives of all the officers lost during services in May. I encourage you to attend some of these to show your support for the men and women that we have lost and to show support for those who are still serving and those who have retired. On April 21-23, NCFOP held our Spring Board of Directors Meeting in Greenville. Pitt-Greenville Lodge 69 was our host lodge for the meeting that began on Friday evening and continued most of the day on Saturday. Our Board of Directors heard reports from our Executive Board members, Committee Chairs, and our Governmental Affairs Director. A lot of good information was shared by all those reporting. Hopefully, that information will be brought back your local lodge so each of you will be informed as well. You can easily email us by visiting the NCFOP website at ncfop.org and we will be glad to get you up to speed.

The 2023-2024 Legislative session began in January and it has been a busy one. Please review the article in this edition by our Governmental Affairs Director on one particular piece of legislation we have been working on for many years, H214 - Add A Member to CJ Training Standards Commission. We appear to be closer than we have even been to getting this done. We will need everyone's support in order to get this bill to the floor and then passed. If you have a relationship with your local legislator, please give them a call and ask for support. The same bill was introduced in the NC Senate, S161, so you should also call your State Senator and ask for support. There have been many bills introduced in both the House and Senate that we are tracking to include 25 Year Retirement, Right to Appeal Giglio Notification, Return to work after Retirement, Medal of Valor for Emergency Responders, and many more.

Please do not forget the upcoming 66th Biennial National FOP Conference and Expo. Time is running out to make hotel reservations for the August 13-17 National Conference in sunny Las Vegas. Where else can you go and find 5,000 of your favorite FOP members from around the country representing 365,000 members from our organization? If you need information, please send me an email or give me a call.



National Lodge Update

The National Board of Directors meeting, Southern States meeting and NC Board of Directors meeting have all recently been held so this is some timely information. Those that attended our NC Board of Directors meeting may find some of this information repetitive as it was in my written report for that meeting. The challenge is that only about 65 members receive that written report so I have to get information on National Lodge activity to the other 5900 NCFOP members thru the BlueNote. The below information is not all inclusive but is a summary of some of the more important issues. You should always go to FOP.net to see what is happening with your National FOP.



One of our guest speakers at the National meeting was the new Director of the Office of Community Oriented Policing (COPS). This director is one of our own,

Hugh Clements. Director Clements served as the National Trustee from Rhode Island for a number of years. He still has great respect for the FOP and made it clear he is a true friend and will do everything in his power to help the officers still working the streets. Director Clements received a very warm welcome and standing ovation from the FOP Board with which he served.

The FOP continues to be the voice of law enforcement across the country. In 2022 the FOP had 38,746 print media mentions with the second closest law enforcement organization having only 9193. Our lead in television and radio mentions was even greater with the FOP having 12,073 and PERF having only 900. Your national, state and local FOP leaders are making sure the public know who we are.

There hopefully will be a book available at the National Conference in August entitled "Safeguarding Freedom". This is a look back at the history of the FOP from its very beginnings to current day. It will examine the contributions the FOP has made in the professionalism of our officers and the hard work that has been done to improve working conditions, salary and benefits. Those that have seen some parts of the work in progress say that it will be a very high-quality book that tells our story in an excellent manner. The author writes with James Patterson, who most of you know is one of the most prominent authors in today's literary world. We should all be looking forward to seeing our rich history put down in writing for all to read.

Our FOP free college program has been a very popular benefit that many officers have taken advantage of to further their careers. The US Department of Education notified colleges some time back that they could not use the funds they had been using to provide this benefit to officers. Appeals have been filed but no final decision has been reached as of this date. Most schools have changed to a "low cost" plan until a decision is made. Eastern Gateway Community College is still providing these free courses at their own risk until the case is heard. You may go to the National website to get more details and stay up to date.

The National Lodge has finally been able to establish participation in a Healthcare Trust Program. This enables the NFOP Healthcare Trust to offer medical benefits through Blue Cross and Blue Shield to some members that have not yet reached age 62. The rate and benefits seem to be very competitive. You will hear more about this in the near future. Aetna is still providing an insurance option for those members that have reached Medicare age.

Our National Legal Plan continues to be very popular and strong. We have assets of approximately 36 million dollars. This certainly seems like a lot but we have a few cases, such as the one in Kentucky involving the Breonna Taylor officers that could end up costing 3 million dollars. These officers were cleared in State court but now the Feds have decided to try them! Our training session at the Southern State meeting featured Jonathan Mattingly, the officer that was shot in the Breonna Taylor incident. His presentation was excellent and gave great insight into what an officer in this situation could face and how the FOP could do better to help that officer through the difficult challenges. I am so thankful that we went

to the national plan for our criminal and civil coverage. Our state self-insurance plan could not have handled a 3-million-dollar case.

Lodges should have made plans to attend the National Memorial Service in Washington in May. The service this year will honor 443 officers that lost their lives in the line of duty. It will take over 50 buses to transport the families to the service and the Auxiliary is looking for officers to volunteer to assist. They try to have one officer on each bus to help the families with any of their needs. I will be assisting the National FOP in presenting medals to the family members when they come forward to place a rose on the wreath. This is one of the most rewarding but emotional tasks in which I have ever participated. To see those family members, especially the kids, and think what they have been through is a very moving experience.

Speaking of the National Conference, two cities so far have announced they are bidding for the National Conference in 2027. Those cities are Salt Lake City, Utah and Chicago. Both cities have met the qualifications so the delegates at this year's conference will vote on a final location. Just a reminder that the 2025 conference will be in Miami. I hope every lodge has made plans to send their delegates to this year's conference in Las Vegas as NC needs all the votes we can provide. There will be some very important votes taken that will shape the direction of your National FOP for the next two years.

Several years back the FOP Board of Directors approved the creation of a for profit corporation so that we could receive fees that are paid from companies that provide services to our members. These fees normally go to brokers but now our own corporation is able to receive them. For the FY 2021-2022, the National Lodge received \$878,222. This figure does not include another \$700,000 saved from the changes we made in our old printed copy of the Journal magazine.

The National FOP Diversity Committee is sponsoring a Diversity Conference October 8-11, 23. This Conference will again be held in Charlotte and Lodge 9 will be helping to make this event successful. Last year's conference was well attended and it is expected that this one will be even larger.

Several new benefits were recommended by the Program Development Committee at the meeting and were approved by the Board. You will be able to go to FOP.NET in the near future and review these and other vendors the FOP supports.

Most of you that follow the National FOP news or attend conferences know that FOP District of Columbia Lodge 1 has been having some difficult times the last few years. There has been much dissension within the lodge and they are facing some investigations over their fundraiser involving Jack Daniels products. The National Lodge has been working for several years to help them work through their problems. There have been grievances filed by members against the past president of DC Lodge 1 and current president. These two officers refused to even hear the actions as required by the FOP Constitution and By-Laws. They rejected directions of the National Board of Directors and their members to hear these grievances as required. Several National FOP Committees had been trying to work with DC Lodge 1 and bring them into compliance. The National Grievance Committee finally heard the complaints of the DC Lodge 1 members and sustained the allegations against the president and past president. It was the unanimous recommendation of the Compliance Committee that the past president and current president be expelled from the Order. This was a sad day for many on the National Board of Directors but the expulsion was approved by an overwhelming majority. The vice president of DC Lodge 1 was sworn in by National President Yoes as president of the Lodge. We cannot have our leaders refusing to follow some of the most important rules of our Order. This decision can be appealed to the delegates at the National Conference so some of you may see all of the investigation report if the expulsions are appealed.

NC FOP and COPS Celebration of Life event on April 18 was a great success. It appeared to me the survivors enjoyed the ceremony and the church hosting the attendees did a fantastic job. Attendance was good but I did not see as many FOP members as I would have liked. Please attend next year as this is your event honoring those that paid the ultimate sacrifice in North Carolina.

I continue to be honored to serve as your FOP National Trustee. All of you should be as proud as I am to be part of this 366,084-member family. Please let me know if I can do anything for you or your lodge.

FOP Legislative Update

The NC General Assembly convened in late January for this year's session. This session's main objective is passing a state budget for this biennium. The State House passed its spending plan on Thursday, April 6th. Now the State Senate will work on their respective budget and there will be a conference committee of members of the State House and State Senate to present a budget to Governor Cooper.

A major initiative for this year's session is the FOP's interest in adding a seat for the organization to the NC Criminal Justice Education and Training Standards Commission. The FOP has had this as a priority for several years.

House Bill 214 was introduced by Rep. Riddell, Rep. Hardister, Rep. Bradford and Rep. Cunningham and would add a seat on the NC Criminal Justice Education and Training Standards

Commission for the FOP and the PBA. The bill has 61 bi-partisan sponsors, which is over half the State House. The bill passed the Judiciary 3 Committee on April 5th with unanimous support. The NC Sheriffs' Association and NC Chiefs of Police spoke against the bill, and it still passed with unanimous support.

The bill now moves to the House Rules Committee which we anticipate being heard soon.

A companion bill has been introduced in the State Senate. Senate Bill 161 was introduced by Senator Jarvis, Senator Hise and Senator Hanig. The bill has a total of 19 bi-partisan sponsors and currently sits in the State Senate Rules Committee.

We need all FOP members statewide to contact their respective representatives and senators and encourage passage of this legislation.



Preserving Your Lodge's Minutes

Few documents are more important to your lodge than meeting minutes. Minutes preserve the business of your lodge, financial approvals and can protect your lodge and your board members from questions of impropriety or civil liability.

Along with preserving your minutes, it is just as critical that you send those minutes to the Constitution and Bylaws Committee annually. This ensures your lodge stays in compliance.

Most lodges simply take minutes, and they remain in the possession of the secretary. The minutes are never shared with the executive board or preserved for posterity. When the secretary leaves, retires, moves or worse, the minutes often go with them. This exposes your lodge to unnecessary liability. The Constitution and Bylaws Committee has been contacted several times about supplying previous minutes to lodges, but we do not have the ability to preserve multiple years of minutes.


With the advent of technology, it is easier than ever to digitally preserve your minutes and store them. Consider one method; once the minutes are approved, signed and sealed, scan the minutes into a PDF. At that point, you can make copies so that the lodge president and secretary have a copy and a digital copy is stored online, such as in a Google account dedicated to the lodge.

At your next meeting, talk with your board about preserving your lodge's legacy. If you have any questions or need help, contact a member of the committee listed below.

These two organizations came together to develop this Celebration of Life to support the families of those who were lost in the line of duty. This event was the first of its kind and was a huge success. I am sure this will continue for many years to come.

Retired Supreme Court Justice Sam Ervin was the guest speaker. He has always shown and given his support to law enforcement throughout the many years he served.

President George W. Bush said it best. "It takes a special kind of person to serve in law enforcement. Most people run from danger law enforcement runs toward it. You've chosen one of the toughest jobs in the world. And I suspect during times of dangerous duty or lonely patrols, it might seem like the only person you can depend upon is each other. Days like today I hope not only helps our families, but helps those who serve remember that a larger community here in this country stands with you, that we're grateful for your service."

Those who gave their lives in the line of duty are heroes. They are heroes not only because of how they died but because of how they lived. The courage shown during the last few moments of their lives was not an unusual event but a daily one.

God created the Police Officer knowing the hearts of men and that criminal acts would take place. He knew that people would need help at times and order would be needed to maintain a peaceful life. Our Fallen Brothers and Sisters knew of this when they took the oath to Protect and Serve and that someday they may be called by Him. We are reminded in Mathew Chapter 5, "BLESSED ARE THE PEACEMAKERS, FOR THEY WILL BE CALLED THE SONS OF GOD."

We must never forget that *Some Gave All*, and that *All Gave Some* every day they wore the badge. The ones who gave all are the ones that gave some until their last day.







Photos of Lodge 10 Grand Opening










Celebration of Our Law Enforcement Heroes & Recent Events

On April 18, the NCFOP and NCCOPS <u>Celebration Of Our Law Enforcement Heroes</u> was held at the Lamb's Chapel in Burlington. Our Celebration recognized the 9 Officers who lost their lives in 2022 and the 2 Officers from 2021. This first ever Celebration of Life was well attended, and in my opinion, a huge success and very much appreciated by the survivors. I have only received positive comments on this event. The Lamb's Chapel was an excellent facility for this event and the Church's personnel were most accommodating, happy to contribute to this Celebration, and extremely generous.





I just returned from the Board meeting in Greenville and I am excited about our future as a State Auxiliary! This is largely due to the continued support of the FOP!

At the meeting, I talked about expanding the Auxiliary to more lodges in our state but I did not go into the benefits a member receives or how to start one. Let me give you a few details! These are a few things that we are a part of, but we are also privy to most of the benefits that the FOP member receives:

- <u>The National Peace Officers' Memorial Day Service</u>: This service is on May 15th on the West Lawn of the Capitol in Washington, DC. The Auxiliary organizes this event with the help of the FOP.
- The National Law Enforcement Officers' Memorial: The National FOP Auxiliary is the only law enforcement support organization that provided seed money to the Memorial Fund and hold a seat on the Board of Directors.
- <u>Accidental Death and Dismemberment insurance</u>: This is provided at no cost to our members.
- <u>Kathryn Milton Scholarship:</u> The Auxiliary provides an educational grant to a dependent child of an FOP Auxiliary member to help pursue their education.
- <u>Easter Seals and Special Olympics</u> are 2 programs that we support.

To start an Auxiliary, you will need 10 family members (spouses, siblings, children over the age of 18, in-laws, cousins, a widow/widower of a FOP Member, etc.) to apply for a Charter. A \$150 Charter fee and a letter from the FOP expressing their support will need to be sent to the National Auxiliary Secretary. Once approved, one of the State Board Members will come to swear in the new board and help them create a Constitution and By-Laws and show them how to run a meeting.

The FOP Auxiliary is the only national support organization of its kind. We are an ancillary organization of law enforcement officers. Our main objective is to support the law enforcement families. We are the spouses who understand living on low salaries and high stress levels. We are the mothers and fathers who support their child's career choice. We are the children who grew up watching a parent come to an event in full uniform.

We were organized to unite families of members of the FOP, to promote their welfare socially, morally and intellectually, and to encourage them in all things pertaining to their good.

Retirees - Did You Know

The Committee wanted to provide you with some information in case you may have missed this. This information concerns Legal Defense Plan coverage for retirees and how to get it.

NEW RETIRED LAW ENFORCEMENT CONCEALED CARRY LEGAL DEFENSE COVERAGE

The FOP Legal Defense Plan's Board of Trustees ("Board") has had numerous requests from current and prospective participants to review broadening coverage under the current HR-218 LEOSA Plan. After diligent review and analysis, the Board voted to make the following changes:

The current HR-218 Plan coverage will be replaced with the FOP Retired Law Enforcement Concealed Carry Legal Defense Coverage (CCC). The expanded coverage will offer Unlimited Legal Defense for civil and criminal claims associated with the legal carrying and/or use of a weapon: all reasonable and necessary Legal Defense Costs are now covered in full when using a Plan Attorney. This new expanded Plan will provide coverage not only for those retirees who were qualified under LEOSA, but also those retirees who are qualified under their own state laws to carry a concealed weapon.

The Concealed Carry Coverage (CCC) will go into effect on January 1, 2021. If you are a current HR-218 retired member, unlimited coverage and the enhanced benefits will automatically take effect on January 1, 2021, with no additional cost. Upon renewal of your coverage in 2021, the new annual fee of \$75.00 will take effect. For all new retired members joining the Plan after January 1, 2021, the annual fee is \$75.00.

If you are an active law enforcement officer covered by the FOP Legal Defense Plan, LEOSA coverage already is included. Concealed Carry Coverage (CCC) is for Retired Law Enforcement Officers Only and separate from the FOP Legal Defense Plan.

The Board is excited to provide yet another excellent benefit for our FOP Law Enforcement Brothers and Sisters. In today's unstable times, it is crucial to make sure you are protected.
